2019 Festival Rules and Regulations

1. Once applicant has been approved, a permit shall be issued. This permit may not be sold, assigned or transferred.
2. Applicant is responsible for occupying and being present at tent for the entire duration of the event, with the exception of short breaks Failure to do so will result in dismissal of the festival.
3. The Festival directors have the sole discretion to decide the placement of the applicant's tent.
4. Payment for event participation is non-refundable.
5. Sharing a tent is not permitted, with the exception of collaborating teams that have been pre-approved by the Festival directors.
6. Applicant must provide his/her own materials to decorate his/her tent space. Tent decorations are to be: (a) attractive and (b) decorated with the appropriate signage. Balloons and other decorations that protrude the confines of the tent are prohibited.
7. Applicant may not sell or distribute any food, beverages or merchandise which have not been disclosed in the application. The Festival directors reserve the right to stop the sale of any above-mentioned items.
8. Applicant hereby warrants and represents that he/she or it (corporation) is an independent contractor and has a certificate of General Liability Insurance.
9. In the event of a loss, injury or property damage, the applicant shall be liable for his/her actions and property losses.
10. Offensive sound/music equipment are prohibited.
11. Styrofoam cups, plates, etc. prohibited in the City of Coral Gables.
12. Applicant must supply and use durable plastic trash bags for the proper disposal of all trash in receptacles. The tent space must be kept clean and organized at all times. A \$50 fine will be applied to any applicant that does not remove all trash and belongings from their tent space at the end of the Festival.
